e.1 ONTARIO COLLEGE OF TEACHERS

Chair Horwitz welcomed Mr. Joe Jamieson to the DCPIC meeting. Mr. Jamieson introduced his role as Deputy Registrar and introduced Ms. Kathy Ansett, External Relations Officer. Mr. Jamieson provided a PowerPoint presentation to the DCPIC Council members sharing information on - What the College of Teachers does; Membership in the College; etc..

Mr. Jamieson discussed Teacher education in the Province of Ontario; Additional teacher qualifications and the Standards of the teaching profession and how on the OCT web site you can find a teacher. A brief question and answer period followed.

e.2 SAFE WELCOME PROGRAM AND FOB ENTRY DEVIDE FOR ELEMENTARY SCHOOLS

Superintendent O'Reilly introduced Superintendent Tim Robins, Facilities Services and Mr. Grieve, Supervisor, Energy and Building Systems to the DCPIC members. Superintendent Robins provided committee members with a brief scenario of an incident that took place in Toronto in 2005, which promoted the Ministry of Education to implement safety precautions for our students and staff while attending school. Superintendent Robins spoke of the impact that this incident and other incidents around North America and how the safety of our students and staff is imperative. Superintendent Robins provided details as to the roll-out of the Safe Welcome program – he indicated the importance of the buzzer system at the front door and provided further details as to whom, when and how this system works to keep our children and staff safe. Mr. Grieve provided information pertaining to the technical background on how the buzzer and the fob systems work in our schools. A brief question and answer period followed.

AODA – ACCESSIBILITY ACT

Superintendent Robins and Mr. Grieve provided members of the committee with a presentation on the importance of having accessibility to all individuals who enter facilities of the Durham Catholic District School Board. Mr. Grieves provided a PowerPoint presentation outlining the Multi Year Accessibility Plan, which can be found on the DCDSB web site at the bottom of the page (see the disability icon) information was shared with committee members pertaining to Bill 125 Ontarians with Disabilities Act, 2001 and other acts and regulations associated with disabilities. Mr. Robins advised that all staff are to be trained with respect to the Accessibilities Act. Mr. Robins and Mr. Grieve provided answers to a few questions from DCPIC members.

Mr. O'Reilly thanked Mr. Robins and Mr. Grieve for providing the committee with information on two important issues pertaining to our schools.

DISCUSSION ITEMS

f.1 OREINTATION AND COMMISSIONING MASS REVIEW

Superintendent O'Reilly, Resource, thanked all members as well for the amazing day, he advised members that a feedback form was sent to all Principals/Vice Principals. The resources provided to schools from the DCPIC were greatly appreciated.

f.2 BREAKFAST CLUB

Ms. Sharmaine Doyle spoke to members of the committee of the breakfast program indicating that some schools do not have a program – a suggestion was made to have Durham Health and Nutrition provide the committee with a presentation in the New Year. Trustee Corless advised members that funds are available to assist with school breakfast programs on an as-needed basis with the approval of the Board.

f.3 RESOURCES IN OUR SCHOOLS - TEXTBOOKS

Superintendent O'Reilly provided an overview regarding a typical school budget he explained that resources are set by the curriculum Guidelines set forth by the Ministry of Education - these guidelines can be found by accessing the Ministry of Education web site at <u>www.edu.gov.on.ca</u>. Superintendent O'Reilly spoke about textbooks in the classroom, technology in the classroom and how the classroom has evolved with Smartboards, IPads, etc. Textbooks are in the classroom, however, teachers through their school could decide on the way to teach a curriculum subject and this may not necessarily be through a textbook.

A suggestion was made to have Program Staff attend a DCPIC meeting in the new year to provide members with resources and best practices on how they teach our students.

A question period followed the presentation.
